According to the Organic Act on Prevention and Suppression of Corruption, B.E. 2018, Section 128, paragraph one, it is prohibited that any government official who receives property or benefits may calculate it as money from anyone other than property, or benefits that are appropriate according to laws, rules, or regulations issued by virtue of

according to the provisions of the law Except for receiving property or any other benefits in a fair and ethical manner according to the criteria and amounts specified by the NACC and the Police Code of Ethics 2021, Section 2(2), honest name. Performing duties according to law The regulations of the Royal Thai Police are transparent and do not display behavior that is suggestive of exploitation. By failing to take responsibility for human rights duties Be ready to receive audits and accept responsibility. have a good conscience Consider society and item 2(4), think about the benefits of the public more than personal benefits, have a public mind, cooperate, join together, and make sacrifices in doing benefits for the public and create benefits and happiness for society In addition, the country's reform plan opposes the prevention and suppression of corruption and misconduct. Goal 1, Step 1.1: Have all government agencies announce that government officials will not accept gifts and gifts. All kinds of gifts from performing duties (No Gift Policy). Therefore, in order to prevent conflicts between personal interests and public interests (Conflict of Interest), accepting bribes, gifts, presents, or any other benefits that are passed on in the performance of duties. Thung Mon Provincial Police Station Therefore, guidelines for anti-bribery (Ant-Bribery Policy) and not accepting gifts have been established. Gifts or other benefits (No Gift Policy) from performing duties with details as follows:

objective

1. To prevent or reduce the opportunity to receive bribes. Conflicts of interest in various forms To police officers under Thung Mon Provincial Police Station
2. To promote the police service Under the jurisdiction of Thung Mon Provincial Police Station Have a conscience in refusing Receiving gifts and all kinds of favors in the performance of duties

3. To create an ethical and transparent organizational culture. (Organization of Integrity) of the bureaucracy.

4. To determine measures, guidelines, and mechanisms to prevent giving/receiving bribes or any other benefits.

5. To determine guidelines for receiving certification. or gifts for executives and police officers under their jurisdiction

Scope of application

Used to protect the liver of every police officer under Thung Mon Provincial Police Station.

Definition

"Bribe" means property or other benefits given. to a person so that he or she will act or omit

What actions do you perform in your position? Regardless of whether it is illegal or illegal according to the payer. A bribe requiring a gift, present, or any other benefit that affects the performance of duties" means money, property, services, or any other benefit that has value and includes tips. which government officials receive in addition to their salary Income from government benefits in normal cases and affecting decisions, approvals, permissions, or anything else in the performance of duties in a manner that is beneficial to Corruption towards the gift giver either in the past or while receiving or in the future.

"Property*" means property and incorporeal objects. which may have value and may be held, such as money and house

"Receiving property or any other benefits in an ethical manner" means receiving property or any other benefits from relatives or from people who give them on various occasions, usually according to customs, traditions, or culture, or according to the etiquette practiced in society.

"Relatives" means parents, descendants, brothers and sisters. or sharing the same father or mother, uncle, aunt, spouse, ascendant or descendant of the spouse. Adopted child or adoptee

"Other benefits" means things that are worth mentioning, such as price reductions, receiving information, receiving services, receiving training, or anything else of the same nature.

“Performing duties” means the actions or performance of duties of a government official in an appointed position. or has been assigned to perform any duties or to act on behalf of the government in any one of the duties

General and specific as a police officer that the law has specified authority or duties

Go according to the authority specified by law to have the authority to request the police.

"Commander" means the Superintendent of Thung Mon Provincial Police Station. who have the authority to command, supervise, monitor and inspect police officers under its jurisdiction

“Puncha” means a police officer under his command. Thung Mon Provincial Police Station Every officer besides the commander

Guidelines for preventing bribery

1. Police officers under Thung Mon Provincial Police Station are prohibited. Be involved in giving or receiving any form of bribe, whether directly or indirectly.
2. Do not allow police officers under the Thung Mon Provincial Police Station to solicit or accept bribes for personal gain. or the benefit of another person
3. Follow the anti-corruption policy. without getting involved in corruption, whether directly or indirectly
4. Performance of duties must be carried out in accordance with police regulations and discipline. and related laws

Strictly do not do anything that is considered giving or receiving a bribe.

6. Supervise the disbursement of expenses of affiliated agencies in accordance with the law. Strictly related regulations

7. Receiving donations or financial support Whether it's money object or property to any activity or project Must strictly comply with rules, regulations, and announcements. and have a receipt or evidence of Receive money for every report

7. Receiving property or any other benefits by virtue of ethics to police officers under Thungmon Provincial Police Station.

Every officer must abide by the announcement. The National Anti-Corruption Commission regarding the criteria for receiving property or other benefits through the ethics of officials, B.E. 2000, is strictly enforced.

Punishment measures/listening to guidelines

1. Violation of not following this policy. May be subject to disciplinary action or criminal proceedings or other laws that

involved, including those who directly enforce knowledge that ignores wrongdoing or acknowledge that there has been a wrongdoing but do not take corrective action which has disciplinary punishment To the point of being fired from government service

2. Failure to be aware of this policy announcement and/or related laws. cannot be used as an excuse

In not being able to comply

3. The commander of the Police Department according to the order of the Police Department No. 1212/1994 dated 1 October 1994 has the authority and duties.

In supervising and supervising subordinates to adhere to and strictly comply with this policy.

Monitoring measures

1. Superintendent of Thungmon Provincial Police Station Announcement of intent to manage the agency with honesty, transparency and in accordance with the principles of good governance. by disseminating publicity to police officers under its jurisdiction and external stakeholders know

2. The commander according to the Police Department Order No. 1212/1994, dated October 1, 1994, has the authority and duty to:

Supervising, monitoring, and inspecting police officers under control under the authority to behave accordingly

According to this announcement In the event that an action is found that violates this announcement Report to the Superintendent of Thung Mon Provincial Police Station as soon as possible.

4. Give the administration department Thung Mon Provincial Police Station Prepare statistics on receiving gifts or benefits.

Measures to protect the deputy complainant and witnesses

1. Consideration of complaints Establish a level of secrecy and protect those involved in accordance with regulations regarding treatment.

Government Secrets Act 2001 and sending matters to the agency for consideration The informant and the complainant may receive

Troubles such as complaints against government officials are initially considered to be It's a government mess if it's a card.

Interesting, consider only those with specified evidence. The surrounding circumstances are clearly evident. Only until the witness is clearly identified.

Reporting information on influential people must conceal the name and address of the complainant. If the name and address is not concealed, the applicant must notify the relevant agency.

involved, know and provide protection to the petitioner as follows The commander shall use his discretion to give reasonable orders to protect the complainant.

Witnesses and persons providing information in the investigation Do not suffer harm or injustice. that may arise from

making a complaint, being a witness, or providing that information" in the case where the name of the accused is specified Must protect both the complainant and the victim.

Complaining because the matter has not yet gone through the fact-checking process. and may be a form of bullying and accusation to gain favor

Trouble and damage can occur and in the case where the complainant specifies in the request that he does not wish to reveal the name of the complainant

The agency must not reveal the name of the complainant to the responding agency. This is because the petitioner may have suffered as a result.

2. When there is a complaint The complainant and witnesses will not be prosecuted. If any action is necessary, such as

Separate the workplace to prevent the complainant, witness and allegor from meeting, etc. Consent must be obtained from the complainant and the witness. 3. Requests from the victim, the complainant, or the witness, such as a request to move the workplace. or methods for preventing or solving problems Should be considered by responsible persons or agencies as appropriate.

4. Provide protection to the complainant. to be bullied

Measures to protect the accused

1. During the consideration of the complaint, the accused is not yet considered guilty. Must be fair and give

2. Give the accused a chance to fully explain the allegations. including the right to present documents/evidence
